SEBI has vide above captioned circular No. had prescribed the common and simplified norms for processing investor's service request by RTAs and norms for furnishing PAN, KYC details and Nomination and has mandated:

- (I) Registering of details like PAN, email address, mobile number, bank account details, specimen signature and nomination by holders of physical securities; and
- (II) Folios wherein any one of the above cited document / details are not available on or after **October 01, 2023**, shall be frozen by the Registrars and Transfer Agent of the Company (RTA) and you will not be eligible to lodge grievance or avail service request from the RTA and not eligible for receipt of dividend in physical mode.

Thereby, we request the shareholders **who have not furnished/updated complete details** as mentioned above in point (I) **to furnish the details/documents** (Form No. ISR-1, ISR-2, ISR -3 & Form No. SH-13 / 14) as applicable, to the office address of our RTA as mentioned below:
